AGREEMENT OF PHILOSOPHY

TUITION PAYMENT

Annual tuition is due May 1. As a convenience, BCS offers a monthly payment plan (May-February). Families selecting the monthly payment benefit will be required to pay by ACH (electronic check) and may select to pay on the 3rd or the 17th each month. If a payment has not been made by the 17th of the month, a \$25 late fee will be billed to the account. If an account becomes more than one month past due, I understand that my child(ren) may be dismissed from school. All accounts must be paid in full before report cards or test results will be issued.
